Focus now is on maintaining funding for current programs and services as much as possible Supporting revenue raisers - has sent out survey to gather information about the CoC's attitudes about types of revenue raisers and what is best State HHFDC – Asked to put in Governors Budget 25 million for rental rehousing funds Funding for School Street Development – Supporting HPHA's request for that Identify new committee heads and new members on committees Drafting one pager on priorities – in process

#### Carla Houser – Data Committee Meeting Updates

DHS Proposal was brought to Data Committee –Request is for a 3<sup>rd</sup> Party Data warehouse that would provide the state with data for legislative purposes. Request is coming from Homeless Programs Office and BESD Brian Donahou's office. Main purpose for request – Because of the economic situation that the state is in there will be questions regarding funding of programs

Scott Morishige: If HPO can look at the full array of data on the statewide level without having to burden the Bridging the Gap volunteers or PIC HMIS team, this would better enable the HPO staff to monitor the programs that are state funded.

Meetings with regards to this MOU have proposed these questions:

- 1. Why is client level data needed, how is it protected and why is it needed vs the provision of aggregate data.
  - a. Scott: Data quality issues, duplications could be corrected and clarifying these issues helps everyone as a system. In order to do program monitoring HPO needs client level access. Access to HPO programs client level data vs system wide client level data??? This data sharing may or may not be possible.
- 2. What is the cost to the state, and does it come out to HPO budget and if so, does it have a trickledown effect and thus effect funding to providers?
  - a. HPO has funding internally to purchase the system. Scott does not believe it would cost providers anything.

Scott Morishige: Suggestion to schedule a meeting between the CoC BOD, BESD staff and Harold Brackeen to answer questions about the request.
