Registration fees will cover the added expense. Proposing \$10 registration fee. Sponsorship and donations are being proposed as well to recover some of the funds. Includes tech support (training), registration responsibility, data reports (attendance, etc.), recording capability, CEU credit function as long as they're provided the itinerary and amount of CEU credit requested then they'll issue all certificates and exhibitor rooms. ED Report	 Moratorium – Hawaii not affected by CDC extension. Mediation Center of the Pacific is ready to go. Everyone should be encouraged to start working with landlords and MCP now. Monday meetings with Legal Aid, MCP, State and providers with AUW for accurate 211 resources. Presentations – Lions Cyber Club, Rick Hamada show made connections to landlords and donations. COVID – more testing is being planned to address Delta variant.

	 EHV – HPHA MOU is signed. PIC will be hiring staff to help manage program. Vouchers available 9/1. City still expecting to have theirs available Spring 2022. Outreach – focusing on Waikiki. Resource fairs being planned for Kakaako. NOFA – word is they'll just renew. HUD TA says there is an RFP out there. Not sure if it's completed or not. Planning – new hire for PITC and training institute. She will do a short presentation at August GM. PITC planning is going on. Tentative count will be on Jan 27th. Will coordinate with BTG. 2019 planning grant has plenty of funds remaining. HMIS Grant – HPO has agreed to standardize reports across the continuum. 	
Committee Reports	 OYAB – no report Advocacy – needs an advocacy chair CES Oversight – no report Communications (Kimo) – 501c owns Partners in Care brand. PIC is the fiscal of the CoC. Communications committee recommends clarifying the brand and name. Official 501c3 name is Partners in Care, Oahu's Continuum of Care DBA Partners in Care. Official CoC name is Oahu CoC. Data (Heather) – PIC continues to get access to HMIS from government agencies. Working on a policy defining what the purpose of access to HMIS is for clarity's sake. Planning (Jillian) – Lunch and learns are in discussion, so surveys will be going out to get feedback on topics. Second round of monitor and evals is done. All grantees know where they stand with their grants. HMIS data monitoring will go live on PIC website. Lots of errors and missing data. Wallace reached out to providers to address them and the feedback has been really positive regarding improvement suggestions. Org Dev (Greg) – see bullets. Will take ownership of keeping the Strategic Alignment planning alive and will report back to Advisory Board. 501c3 – next meeting will be 8/23, no July meeting.
