- Develop a full continuum of services.
- Ensure that homeless persons are treated with dignity and care.
- Engage in planning and evaluation to maximize the use of existing resources.
- Advocate for policies that promote a comprehensive, long-term approach to solving homelessness.
- Work collaboratively with other agencies and groups throughout the state of Hawaii.

Group Agreements

 Inclusivity: Everyone should participate, we will create space for all meeting participants to contribute with one person speaking at a time.
Step up, step back: If you are a person who normally talks a lot, then please try to 'step up' listening and 'step back' talking. If you are a person who normally stays quiet, then try to 'step up' speaking, and 'step back' listening.

3. **Stay on track**: The agenda will be utilized to keep the meeting targeted. When conversations linger on/tangents come up, participants will be redirected to the most appropriate place to continue to conversation (via committees, email correspondences, one-on-one conversations, or alternative meetings, etc.). The Chair will serve as a moderator to keep the meeting on track.

4. **Come prepared**: Anything that needs to get voted on will be provided a few days ahead of the meeting, members should come to the meeting prepared by pre-reading meeting materials.

Maintain and Perpetuate Proven Core Services:

Maintain and perpetuate proven core services (Housing First, Rapid Rehousing, Emergency Shelter, Family Assessment Centers, Homeless Outreach, Civil Legal Services, etc.) by putting into base budget, and to match funding levels to reflect the true cost of these services, such as living expenses increases to allow livable wages for staff members.

Support Housing- Stability Services: Support housing-stability services designed to keep people housed following placement (Permanent Supportive Housing) and maintain rental assistance services.

Creation of Affordable Housing: Encourage the development of affordable housing in Hawaii for those at 80% and below the Area Median Income.
