Clients complete community service hours.</li> <li>HMIS Access would assist in locating clients and informing clients of upcoming court dates.</li> <li>Would like VISPDAT access for three users.</li> <li>Would be inputting CLS, contact info. Would be added to the care team</li> <li>Vote yes pending joining as a PIC partner</li> </ul>
HMIS Data	Overdose Risk Among People Experiencing Homelessness
Requests	<ul> <li>Would like read-only access</li> <li>Other possibilities: working directly w/ providers or receiving deidentified data.</li> <li>Longitudinal study would be hampered w/ linking their data w/ HMIS deidentified data.</li> <li>Plan to revisit in Jan after amendment vote</li> </ul>
HMIS Updates	<ul> <li>Clarity Migration is progressing as expected. CaseWorthy will be shut down Jan 31, 2024. Users should retrieve/save anything they need from CW by end of Jan 2024. Anything prior to 7 years ago is not being transferred over.</li> </ul>
