Planning:

Monitoring and Evaluation

Monitoring and Evaluation will pause through the completion of the HUD funding opportunity. PIC has just completed an audit by the local HUD office for our three main HUD grants: CES, HMIS and Planning. We expect the results of that monitoring in the coming weeks.

Statewide Conference

Registration for the November 3rd conference will be opening in the next several weeks. We have a great group of sessions planned as well as a great keynote speaker. Please keep in mind that tickets will go fast for both days of the conference.

Meeting with HUD Secretary Marcia Fudge

Partners In Care participated in a stakeholder meeting with current HUD Secretary Marcia Fudge on July 3rd. This listening session was productive with PIC requesting two maim things from HUD: 2 year contracts vs. one year contracts and that the NOFO be released at a regular time annually to ensure the best possible applications from the CoCs. Other stakeholders such as Connie from IHS, Brandee from BTG, as well as the Governor, Big Island Mayor Mitch Roth, Congresswomen Jill Tokuda, Hirono and Congressman Ed Case. Many issues were discussed which we hope leads to more resources such as more Emergency Housing Vouchers and other permanent housing vouchers.

HUD Grant Applications

As most of you know, the Notice of Funding Opportunity was released by HUD on Wednesday, July 5th. While the notice was released, it did not have the funding amount within it. Partners In Care has completed and is ready to release the Request for Proposals. Planning and Advisory Board will be meeting on Monday, July 17th and an update will be provided at the General Membership meeting.

Disaster Management (natural disaster/health pandemic)

Hurricane Calvin is our first major weather event this hurricane season. Partners In Care has been attending daily meetings since Friday tracking the storm. At the writing of this report, we expect that the storm will continue to be downgraded, but heavy rains are expected and providers should be prepared for possible flooding and notifying those who are unsheltered. Evacuation shelters will be opened if necessary. Please keep an eye out for updates for the rest of this week.

Emergency Solutions Grant

Thank you all for participating in the questionnaire regarding the CoC suggested breakdown of the ESG program. 31 people responded and the results have been forwarded to the Planning and Housing Committee.

Homeless Management Information System (HMIS) 7/22-6/23:

The new HMIS contract started on July 1st. All funds were expended in the FY '21 grant cycle. Additional funds from the Emergency Solution Grants including reprogrammed funds have been allocated to assist with the transition of the data system from CaseWorthy to Bitfocus/Clarity.

Coordinated Entry System (CES) 9/1/2022-8/31/2023:

CES has just over a month left in the FY'21 funding cycle and all funds are expected to be spent. The CES team is working on updating both the Assessment tool and Written Standards. We hope to complete both by the end of 2023.

Youth Homelessness Demonstration Project (YHDP):

YHDP HMIS 12/22-11/23 There is approximately \$41,000 remaining in this grant which is on target for spenddown by the end of November 2023.

YHDP CES 2/23-1/24 There is approximately \$30,000 remaining in this grant which is on target for spenddown by the end of January 2024.

Oahu Housing Now Project (OHN):

OHN completed it's cycle on June 30th with a complete report on lessons learned and accomplishments and difficulties throughout the program. The report will be on the PIC website once it is approved by the City.

Landlord Engagement Program (LEP):

While the housing market continues to tighten, our LEP team has been working hard to locate housing that is both safe and affordable.
