## Summary Report for HI-501 - Honolulu City and County CoC

### Measure 1: Length of Time Persons Remain Homeless

This measures the number of clients active in the report date range across ES, SH (Metric 1.1) and then ES, SH and TH (Metric 1.2) along with their average and median length of time homeless. This includes time homeless during the report date range as well as prior to the report start date, going back no further than October, 1, 2012.

**Metric 1.1:** Change in the average and median length of time persons are homeless in ES and SH projects.  
**Metric 1.2:** Change in the average and median length of time persons are homeless in ES, SH, and TH projects.

a. This measure is of the client's entry, exit, and bed night dates strictly as entered in the HMIS system.

b. Due to changes in DS Element 3.17, metrics for measure (b) will not be reported in 2016.

This measure includes data from each client's "Length of Time on Street, in an Emergency Shelter, or Safe Haven" (Data Standards element 3.17) response and prepends this answer to the client's entry date effectively extending the client's entry date backward in time. This "adjusted entry date" is then used in the calculations just as if it were the client's actual entry date.

NOTE: Due to the data collection period for this year's submission, the calculations for this metric are based on the data element 3.17 that was active in HMIS from 10/1/2015 to 9/30/2016. This measure and the calculation in the SPM specifications will be updated to reflect data element 3.917 in time for next year's submission.

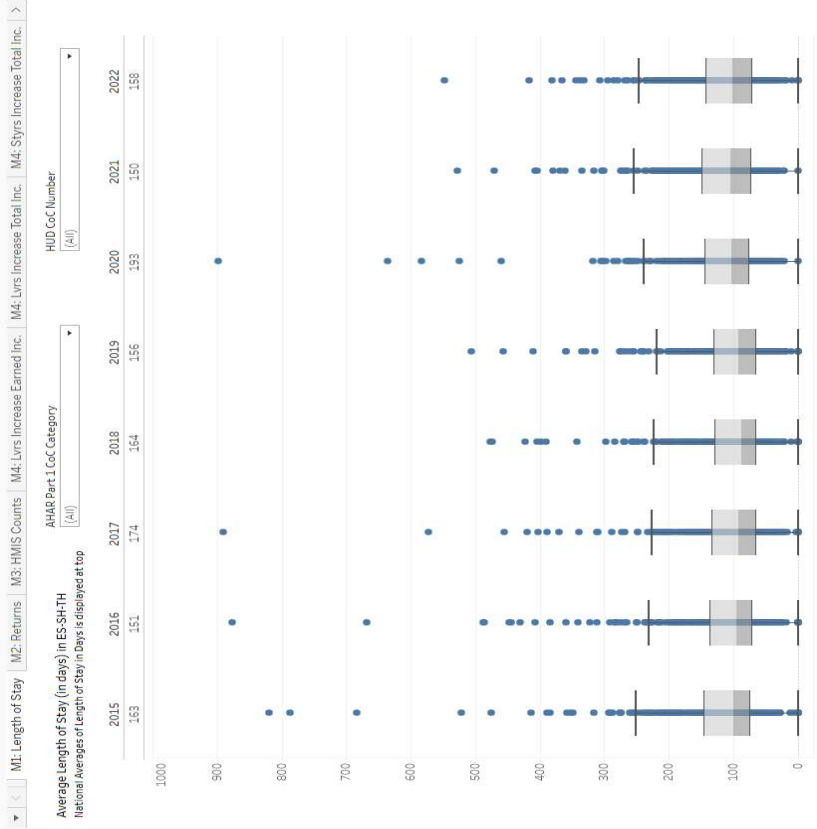

# National Summary of Homeless System Performance 2015-2022

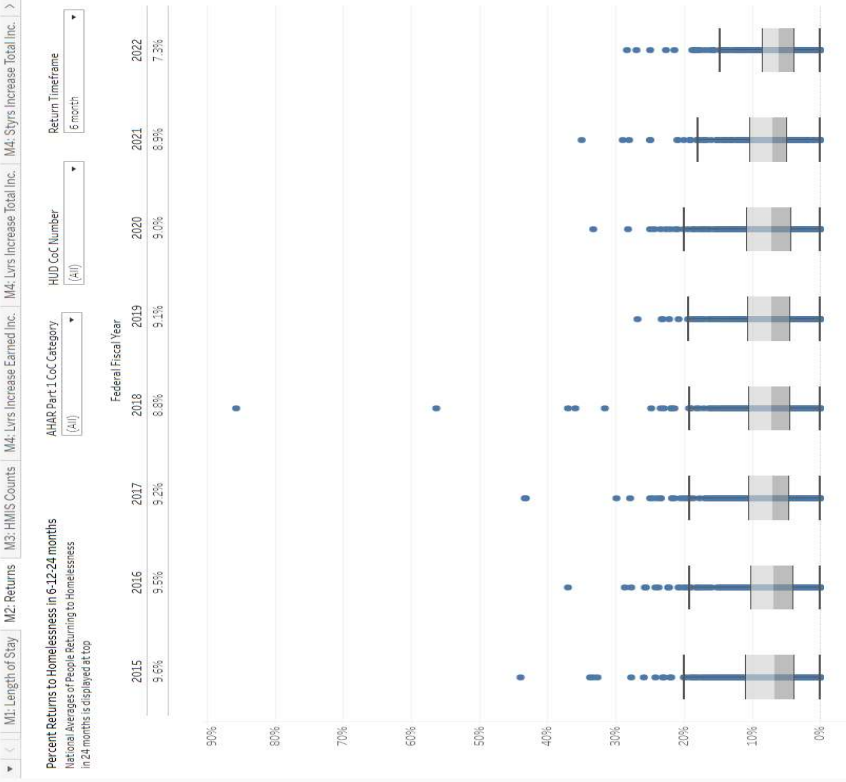
The purpose of the **System Performance Measures (SPM)** is to encourage **Continuums of Care (CoC)**, in coordination with **Emergency Solutions Grants (ESG)** Program recipients and other stakeholders, to regularly measure their progress in meeting the needs of people experiencing homelessness in their community and to report this progress to the U.S. Department of Housing and Urban Development (HUD). The results reported from CoCs for federal fiscal reporting years 2015 through 2022 are posted on the [HUD Exchange](#) and summarized below.

**Measure 1:** The length of time individuals and people in families remain homeless. The SPM results use records from shelter, transitional housing and safe haven stays recorded in each CoC's homeless management information system (HMIS).



The **National Averages for Length of Time Homeless** were calculated by multiplying a) the Point in Time count of sheltered *and unsheltered* people within each CoC by b) the CoC's average length of stay from the HMIS-based SPM, and then c) dividing the sum of all CoC's calculated days homeless by the national PIT count to derive a national weighted average length of time homeless for each year.

**Measure 2:** The extent to which individuals and families who leave homelessness experience additional spells of homelessness. Exits to permanent housing (denominator) and returns to outreach, shelter, transitional housing, safe havens, and select permanent housing projects (numerator) are recorded in HMIS.

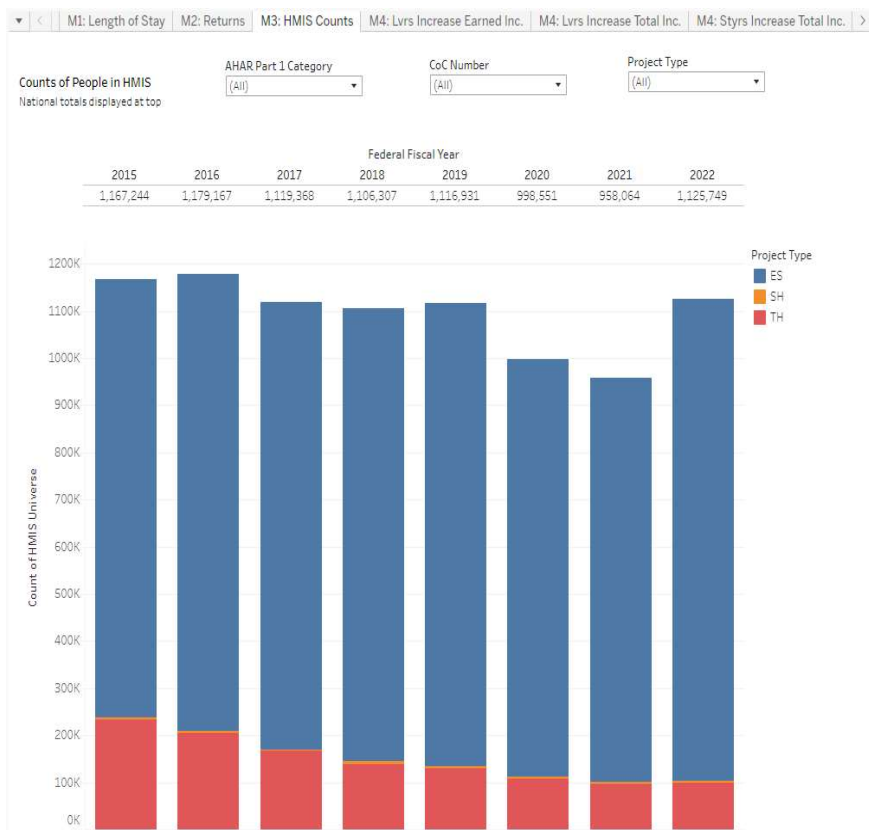


**National Averages for Measure 2** are derived from total counts of permanent exits (denominator) and subsequent homeless entries (numerator).

**How to read these box-and-whisker plots:** The dots represent a single CoC, the light and dark grey areas show the first and third quartile of each set of data, with the median separating the two shades, and the whiskers extend from each quartile to the minimum below and maximum above. **To explore each dataset on this report further, the links for each measure take you to a Public Tableau page.**

**Measure 3:** Overall change in the number of homeless individuals and families, represented as counts of people in each year staying in emergency shelters (ES), safe havens (SH), and transitional housing (TH) projects according to HMIS.

**Measure 3** also looks at Point-In-Time (PIT) counts of homeless on the street and in shelters, safe havens, and transitional housing on a single night in January. Annual PIT count results can be found [here](#).



**Measure 4:** Jobs and income growth for homeless individuals and families, represented as counts of people with increases in earned income and total income from project start to project exit (called System Leavers).

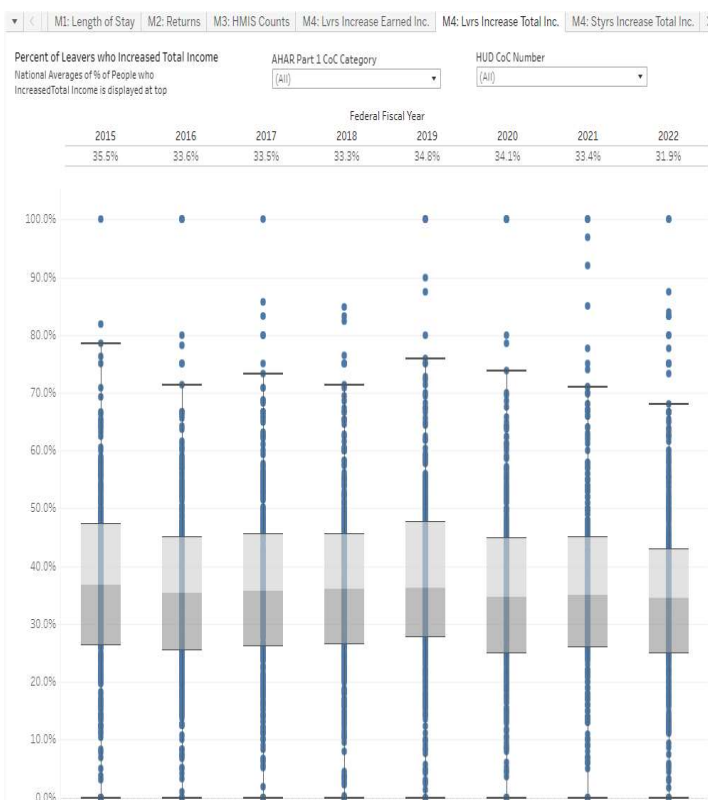
**National Averages for Measure 4** are derived from total counts of people at project start, then a calculation of whether their income increased by the end of their project stay. If income increased, they are counted as "Increasing Income." The types of income counted in "Total Income" and "Earned Income" measures can be found in the [HMIS Data Manual](#).

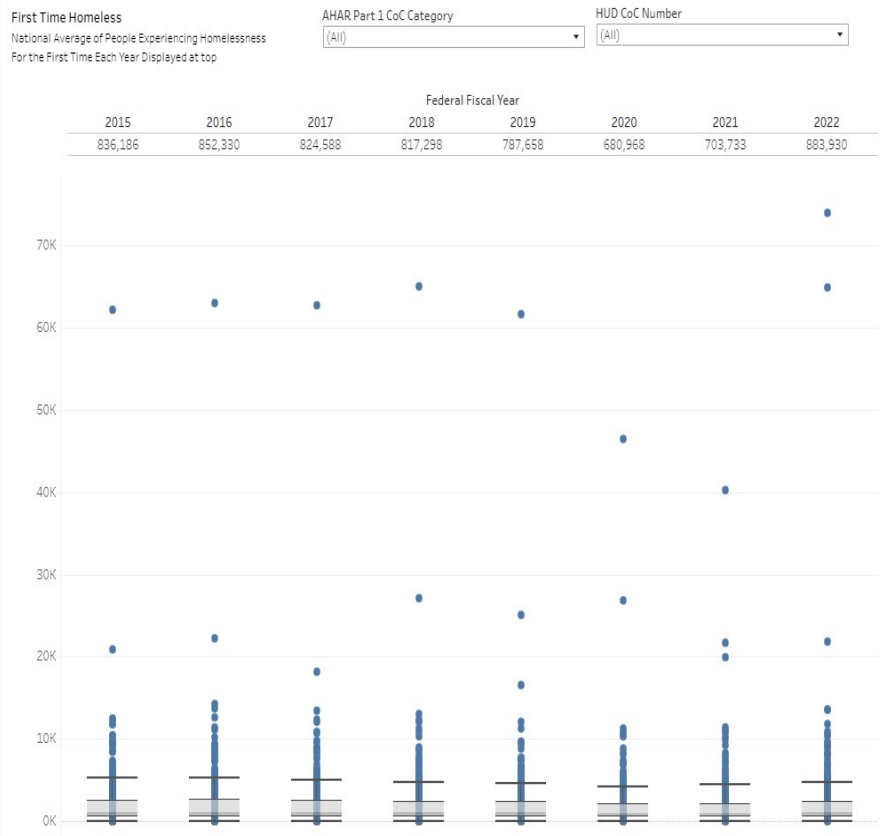

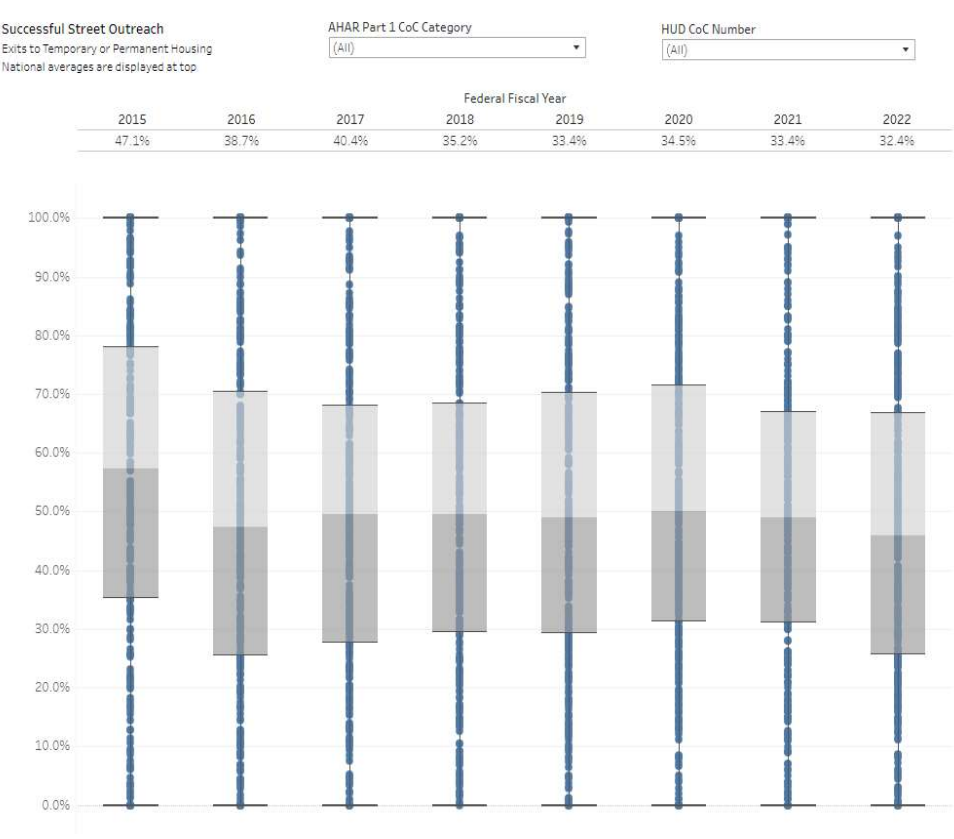
**Measure 5:** Success at reducing the number of individuals and families who become homeless, represented as counts of people without a prior entry to the homeless system according to HMIS records.

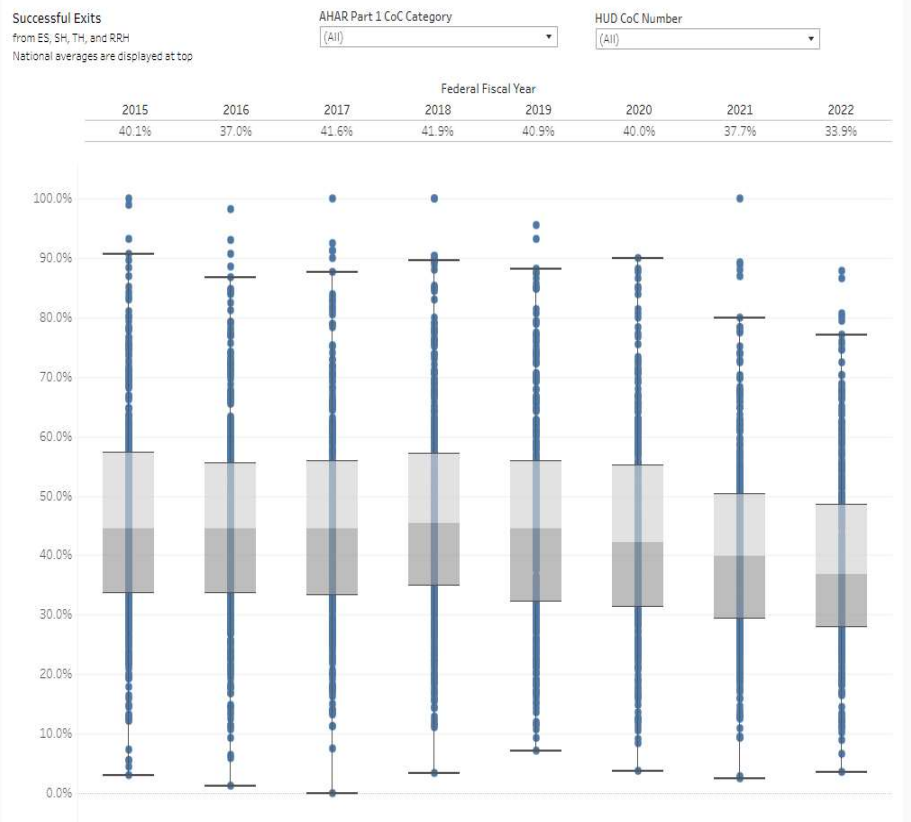
Unlike other housing projects, a “positive exit” from street outreach projects includes exiting to shelters, transitional housing, or safe haven projects because they are viewed as an improvement over living on the street.

**Measure 7b1:** Successful housing placement to a permanent housing destination from Emergency Shelter, Transitional Housing, Safe Haven, or Rapid Re-housing projects.

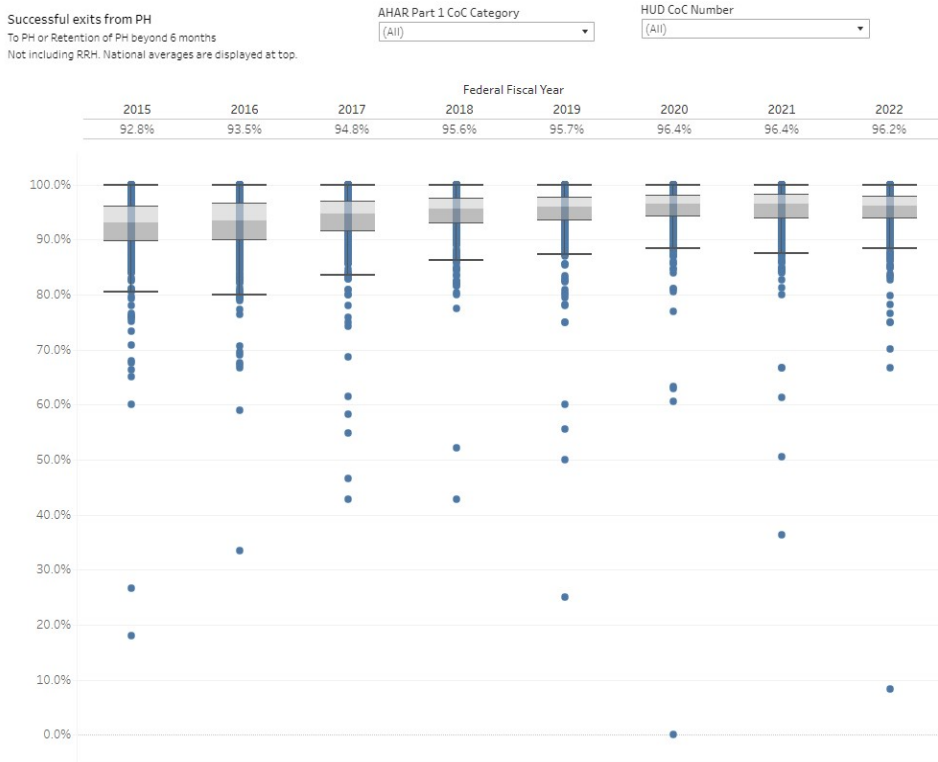
