New Business	 HiHAC Priorities- SB678: Conveyance Tax- purpose is to increase the conveyance tax rates and allocates ten percent of the conveyance tax for homeless services and supportive housing. Tax rates on homes under \$2M = 0.5%Homes sold above \$2M = 6% (majority of these homes are high income investor owners), This money would go to a homeless service fund. 2 other bills discussed: HB1338 – Tenants Bill of Rights HB1339 – Notice Periods Kevin Carney – Senior LIHTC project by Catholic Charities looking for support on their 201H project to be brought to council in February. It is a fort street affordable senior rental housing. Measure: https://hnldoc.ehawaii.gov/hnldoc/measure/2424 Chat box: Housing bills for RHRF and DURF are: HB 925; HB 951, HB 1246 & SB 864 (General Obligation bonds for these programs). Also, SB 1040: funds a Kauhale pilot in the Leeward area by DHHL. HB233/SB357, which creates a state child tax credit, payable monthly, of \$1000/year for children under age 5, and \$500/years for children ages 6-18
